#### Sviridoff's People

For more than a dozen years, the National Affairs Division ranged over a wide array of domestic issues -urban poverty, housing, race relations, women's rights, minority business, conflict resolution, reform of the justice systems, and more. At the helm was Mitchell Sviridoff (1980). Mike then served as president of the Local Initiatives Support Corporation (LISC), which the Foundation had created, until 1985. Joining the New School as professor of urban policy, he organized the Community Development Research Center, where he is now a Senior Fellow.

Notes on the post-Ford careers of several of Sviridoff's people were reported in issue No. 1 of The LAFF Society newsletter. New communications have since been received from: William Grinker

(1974), who founded Manpower Demonstration Research Corp. (MDRC). He left there in 1982 to set up a consulting firm and SEEDCO. Bill then became New York City's Human Resources Commissioner, where he served until 1989. While commissioner he recruited another FF alumnus, Gordon Berlin, to the City as executive deputy. And, to close the circle, Berlin is now at MDRC. Grinker is clinical professor at the New York University Wagner School of Public Administration. Robert B. Goldmann (1982) until 1986 ran a professional foundation for three smaller institutions for the Federation of Jewish Philanthropies. Then joined the Anti-Defamation League (ADL) staff, directing its West European office, in Paris. There he became a columnist for the International Herald Tribune. the pro bono ministrations of Paul H. Feinberg, a Cleveland lawyer who once labored in the Foundation's Office of General Counsel, The LAFF Society is now a tax-exempt organization under the regulations of the Internal Revenue Service -- a 501(c) (7) organization, "social club." But we are not a charitable organization, so dues and other contributions do not earn you a tax deduction. We have filed form SS-4, which earned us a Taxpayer Identification Number. We have also filed the short form for exempt organizations, 990EZ, but Paul advises that we do not have to file an application for exemption, particularly if the Society's gross receipts do not exceed \$5,000 (as the expression goes, "We should live so long.").


Quite as valuable as cash contributions are the names and addresses of FF alumni, and news from them about the paths they have followed since they left the Foundation.

#### Booked Up

Overlooked in this column in the last issue was the acclaimed biography of Presidential candidate Adlai Stevenson, by Porter McKeever (1956). Titled "Adlai Stevenson: His Life and Legacy" it was published by Morrow (1989).

One of the most controversial books in recent memory was written by **Gary G. Sick** (International Affairs, 1987). "October Sur-

prise: America's Hostages in Iran and the Election of Ronald Reagan" (Random House) presents evidence for the assertion that senior officials of the Reagan campaign negotiated a secret agreement with Iran to delay the release of the hostages until the Reagan-Carter election was over. Sick served on the staff of the National Security Council in the Carter administration. He is now at Columbia University.

#### In Memorium

Bernard McDonald (Urban Poverty, 1989), died in October of a heart attack. He was 49 years old, and at the time of his death was a senior fellow at the Pratt Institute Center for Community and Environmental Development. Bernie, an expert on antipoverty issues, worked in community development for more than 25 years, including nine years with the Bedford-Stuyvesant Restoration Corporation. the nation's first community-based development corporation. Bed-Stuy was headed by Franklin A. Thomas, who went on to become president of the Foundation. Bernie joined the Foundation in 1978 to help establish programs in community development, urban education, and youth employment. He directed the urban poverty program from 1981 to 1987, then its Special Project on Community Development.

Howard Swearer (Howard R. Swearer, 1970,

former president of Brown University, died in October, 1991, at the age of 59. Francis Sutton was vice president, International Division.)

It was never hard to see that Howard Swearer was an exceptional man. I first met him when I was circuit riding to find out what had happened with John Howard's big international studies grants of the early and middle Sixties. When I got to UCLA I had the usual array of meetings but I also had breakfast with Howard alone. At the end of it. I thought. "We should have this fellow on our side of the table." Fortunately, we were in the heady early months of the Bundy-Bell era and I was able to offer Howard a job on my own staff. Too soon we needed him to head the European and International Affairs office and, again too soon. Carleton stole him away. I'm proud to have lured Howard to Ford. He was one of the best we ever had and with his grin, his wit and his jokes, he kept down the solemnity that plagues philanthropy. One didn't need to know him long to feel the toughness under his ease and amiability, the tenacity through hard problems, and the firmness of principle that made others of us do the right thing. He left Ford too soon and now he is gone for good, all too soon.

#### The Black Ink Report

The following is a cumulative statement, through Dec. 20, 1991. Income, except for a bunch of pennies from bank interest, comes from contributions of former FF staff members. These are, as one wishes, dues, subscriptions, or contributions. In any case, they are not eligible for income tax deductions.
